### **Police**

#### **Chief Steve Griffin**

We have had some complaints about a few ordinance violations recently. Just as a reminder, if you will be doing some home improvements on your property, there are city ordinances that outline what is acceptable when it comes to debris removal. As an example, construction dumpsters cannot be placed on any roadway in the city. These dumpsters must be placed on your property from the time they are dropped off until they are picked up. If there are questions, all city ordinances can be viewed on the city website at

<u>www.hurstbourneacres.org</u>. All Louisville Metro ordinances are also in effect and these ordinances can be viewed at

https://louisvilleky.gov/government/codesregulations/local-ordinances .

It should also be noted that ordinance violations are a civil and not a criminal matter therefore the police department cannot enforce ordinance violations. I have been tasked by the Mayor with the additional responsibility of Code Enforcement. If a complaint of an ordinance violation is received, I will investigate to see if the violation exists and if so, I will then notify the resident/owner of the violation. Notification will be made either verbally or with a written Courtesy Notice of Violation. The ultimate goal of the city is to resolve these issues through voluntary compliance, if possible. If the matter is not resolved voluntarily in a timely manner, a written Citation of Violation may be issued at the discretion of the Mayor/City Commission. The Citation of Violation will outline the issue, list what must be done to settle the issue, list the monetary fine that has been imposed on the violator, and will outline the process to appeal the issue to the City Commission. If the issue is not resolved at this point, the matter would need to be referred to the Jefferson County court system for adjudication/mediation. Obviously, taking any matter to civil court is both time consuming and expensive to all parties involved so once again, the ultimate goal of the city is to resolve these issues through voluntary compliance, if possible. Also note, there are other courses of action available if the violation poses an immediate risk to health or public safety. Please feel free to contact the Police Department if you have any questions or concerns about any ordinance violation issues.

# Streets and Lights Donna Nichols

With all the controversy regarding the \$25 charge by EcoTech for picking up large items, I am sharing this incident as it happened to me within the last month. I had a two-piece leather sectional stored in my garage for the last year, waiting to get someone to haul it off, since I had gotten some new furniture. #### September Highlights

- All officers completed KLC recommended monthly training.
- Department supported the City Picnic.
- The five offense reports were for a theft from a vehicle on Woodfield, a
- theft from Shoe Carnival, an assault of a resident at the Meadows Apartments, a field information of shots fired in the Meadows Apartments, and a theft of services from Chuck E Cheese. LMPD also took a burglary report on Cardwell.
- Sergeant Beahl resigned from the Department.
- Officer Hile has been promoted to Sergeant.
- All Golden Watch residents checked on weekly.
- All businesses in shopping centers checked on daily.
- Explorer is undergoing brake repairs. All other vehicles are in good working order.

#### **Attorney's Report**

Attorney Cato will be assisting Treasurer Bloomer in the resolution to the amount sent to collections by AT&T for money allegedly owed by Hurstbourne Acres. Concerning the Puppygram store at Taylorhurst, Attorney Cato needs to discuss the situation with prior attorney, Tammy Baker, before taking any further action.

There have been changes in ownership at the Meadows Apartments including no current manager. Attorney Finn and Mayor McAllister will come up with a new plan concerning the progress of getting the sidewalk built along Blowing Tree Road.

Lastly, the new owners of the property, which was once Schumann Antiques, plans on building an exterior elevator to the structure. However, this construction would encroach on a road (old Powerhouse Lane), and so this road must be legally closed before the owners can continue. Although this road was rerouted years ago and renamed Blowing Tree Road, Louisville Metro still shows it on their records as an active, existing road. After the owners submit the appropriate documentation to Louisville Metro, Louisville Metro then makes a recommendation which is forwarded to Hurstbourne Acres. Our city then creates an ordinance closing the road allowing the owners to continue with the construction of the elevator. Mayor McAllister is working with the owners to get this done as quickly as possible.

#### **EcoTech**

Greg Alvey with EcoTech came to the meeting to discuss the hydraulic fluid stains on our city streets caused by their sanitation trucks. The Commission listened to the complaint from resident Jim Lynch and the explanation from EcoTech representative Greg Alvey. Mayor McAllister advised that he would get together individually with Jim Lynch and Greg Alvey to resolve this issue.

### **Thomas Car Wash**

Alex Thomas came to the meeting to discuss the problem with the condition of the ditch at the corner of Taylorsville Road and Hurstbourne Parkway. Although, they have cut it in the past, it is a time consuming and a dangerous job and he wanted to know their options. Mayor McAllister assured him that the land is owned by Louisville Metro and they are responsible for the upkeep. He

has contacted our Metro Louisville District representative to provide our City with a cutting schedule for the ditch.

### **Edward Jones**

Joel Shepherd from Edward Jones outlined the current strategy regarding our City's investments as a result of a current change in the law and the economy.

# COMMITTEE REPORTS Park

Commissioner Eskridge advised there are two events upcoming: leaf pickup and the Holiday Party. The leaf pickup dates are November 7 through 10, November 21 through 24 and December 5 through 8. This information will be included in the next newsletter.

Regarding the Holiday Party, the preliminary date is Sunday, December 11. The Holiday Walk for the homes decorated for the Holiday is also part of the plans for the City.

#### **Sanitation**

Commissioner Bohnenkamp said that although Thanksgiving and Christmas are around the corner, there should not be any change to the sanitation pickup schedule.

#### **Streets**

Commissioner Nichols said that she continues to look for a Christmas Tree for the entrance to the Park. There was a lengthy discussion about how and what decorations to install for the Holidays. Commissioner Nichols advised that she and resident Kimberly Bloomer will work it out.

#### **Police**

Commissioner Renninger reported that there is a problem with exiting the parking lot near the new Modern Vascular business. Specifically, those cars leaving Taylorhurst at that end do not see the stop sign and are disregarding the cars coming down Hurstbourne Lane. It was agreed that a *stop bar* needs to be painted on the pavement at the sign to help prevent accidents. Commissioner Nichols

said that she would contact Hagan Properties to get this done.

Lastly, Commissioner Renninger said that the City, with the last resignation, is down to five officers.

### **Candidates Forum**

Following a discussion, it was agreed that the City will once again hold a candidates forum for the upcoming election. The forum is scheduled for October 23 at the City Hall from 2:00 pm to 3:00 pm.
